Eligibility: One entry per customer, per purchase. In order to submit entries, contestants must be 18 years of age or older (residency not required) and must purchase a musical instrument totaling \$300.00 or more. Upon completion of sale, one entry may be submitted in the name of the purchaser. Entries are non-transferable. Any individuals (including but not limited to employees, consultants, independent contractors, and interns) who have, within the past six months, performed services for Nazareth Music Center or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the contest or supplying the prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, are not eligible to enter or play.
