The NAZARETH MUSIC CENTER rental program is designed to provide students with quality instruments for a monthly rental. After the initial rental, the parent receives a monthly statement showing the amount due for continuing to rent the instrument. There are six groups of rental instruments. They are as follows:

The initial rental payment plus 100% of the consecutive monthly rental payments (Rental Money) including all M&R payments may be accumulated toward the purchase of a NEW NAME-BRAND STUDENT MODEL Instrument (not accessories). Up to 28 months may be applied to Groups I, II, III, IV, & V; 33 months to Group VI. The Renter may continue to rent beyond aforementioned months without accumulating additional Purchase Credit. The customer may return the rental Instrument and purchase a new instrument at any time during the rental period. Rental Instruments belong to NAZARETH MUSIC CENTER and cannot be sold. This is a monthly agreement. To be properly credited, each monthly rental must be paid within 25 days of the "Statement Date" printed on your monthly invoice.

RETURN POLICY

Rented instruments may be returned to NAZARETH MUSIC CENTER at any time thereby terminating the instrument Rental Agreement. The instrument may be returned in person, or shipped by US. Mail, UPS or any prepaid mail service, to NAZARETH MUSIC CENTER. The rental agreement will be cancelled when the instrument is received at our store. There are no Refunds on Rentals.

The customer must notify NAZARETH MUSIC CENTER if the instrument return arrangements are made with the music teacher at your school. Customers will remain responsible for instruments returned to the school in the event the instrument is lost or stolen.

If a rental instrument is returned and a new instrument is not purchased, all rental payments will be treated strictly as rent for the use of the instrument. Rental money is available only for use by the individual account holder who has been renting the instrument and may not be transferred to or combined with any other rental account.

TERMS AND CONDITIONS

NAZARETH MUSIC CENTER BAND INSTRUMENT RENTAL PROGRAM

1. The new instrument that is purchased must be one of equal or greater value, compared to the instrument that was rented and must be of the type included in the Band Instrument Rental Program.
If the customer does not wish to purchase a new instrument, the customer may continue renting the instrument by paying the monthly rental fees. Rental Payments after the credit month period will be treated strictly as rent paid for the use of the instrument and will not increase the rental money which may apply toward the purchase price of a new instrument.
2. Instruments in a specific group are considered to be of "Equal Value" and not to be compared to or exchanged with instruments in another group of "Lesser Value" except strings. The purchase price of the NEW INSTRUMENT will be a Discounted Manufacturers Suggested Retail Price at the time the customer makes the purchase.
*If the customer wishes to purchase a "PRO" or "SEMI-PRO" instrument, 80% of the rental credit may be used to offset the purchase price, with exceptions of Oboe, French Horn, Tenor Sax and Baritone Horn and Strings on which 100% of rental credit may be used.
3. Upon the recommendation of a Band Director or Private Teacher, the customer may exchange the rented instrument for another of equal or greater value as listed in the Rental Program. In this situation, the rental may be transferred to the replacement instrument.
4. Liability from damage. You are fully responsible for the loss, damage or destruction of the instrument from all causes in excess of normal wear and usage up to the fair, current market value of that instrument. You may choose the optional M&R (maintenance and repair) feature to cover some of your liability.
5. Maintenance and repair option. If you choose this option and your contract is current, you will not be liable for the loss or damage to your instrument due to theft or fire. For theft, you must present us with the police report showing forced entry to your home or car within 72 hours of the incident. M&R does not cover the instrument simply missing from a band room, orchestra room or your locker. M&R covers the cost of repairs done unless the damage is from a willful act or negligence. M&R does not cover damage to the finish, cosmetic damage to the case, case feet, reeds, drum heads, sticks or mallets, rosin, oil, or the loss of a mouthpiece. If the mouthpiece is damaged, it will be replaced. You may choose M&R at the beginning of the contract, you may not add it later. We do not exchange instruments that require repair.
6. NAZARETH MUSIC CENTER reserves the right to repossess the instrument if the account becomes delinquent by 3 months. These accounts will be turned over to a Collection Agency. You agree to reimburse us the fees of any collection agency, which maybe based on a percentage at a maximum of 33% of the debt, and all costs, and expenses, including reasonable attorneys' fees, we incur in such collection efforts. Non-receipt of a bill does not exempt liability if a customer fails to notify NAZARETH MUSIC CENTER of a billing address change. By signing this agreement you are allowing us or our agents to contact you via phone, fax, or e mail to collect past due rentals.
7. Instrument title. Nazareth Music Center owns the instrument, you are renting this property. If you declare bankruptcy, we retain the title and the instrument must be returned to us immediately. You do not have the right to keep the instrument unless all of the rental payments have been made, and continue on time.
8. A \$25.00 fee will apply for any check returned for any reason.
9. If a balance due remains unpaid for more than 25 days, LATE CHARGES will be added to the UNPAID BALANCE. The LATE charges will be added to the UNPAID BALANCE. The LATE CHARGES will be determined by applying a periodic rate of 1.5% per month (18.0% annual rate) to the UNPAID BALANCE. By signing this agreement, you authorize Nazareth Music Center to charge the listed credit/debit card for unpaid balances past 30 days.
